In case, the said certificate is issued in a language other than English or Hindi, a translated copy in English/Hindi duly attested by the gazetted officer is required failing which, the candidature will not be considered against reserved post. Further, candidate belonging to OBC category are also requested to produce a recent certificate indicating that he/she does not belong to creamy layer.
3. All original certificates in support of your claim of experience etc. as stated in your application.
4. A certificate from your present employer indicating your designation, nature of appointment (permanent/temporary/ad-hoc) and scale of pay alongwith last pay certificate (basic & other allowances).
5. Applicant employed in the Govt./Semi Govt./PSU whose application has not been forwarded through his employer, must bring "No Objection Certificate" from the employer.
