Sealed Tenders from the experienced agencies for supply of High Speed Diesel of required quantity for a period of one year from the date of allotment. The last date of submission of tender is 26.05.2010 upto 12.30 PM. Tender received will be opened on the same day at 4.00 P.M. in the presence of the authorized representative of Tenderers, if they so desire, at NIT Patna.

Terms & Conditions

- 1. The agency should clearly specify the grade of diesel with rate of supply and should submit duly filled up Annexure I of the Notice Inviting Tender.**
- 2. The bids shall be submitted in two envelopes, viz., a) Technical bid and c) Financial bid. Technical bid should contain papers regarding registration of the firm, clearance from sale tax/Vat, clearance from IT,/PAN, work experience and completion certificate of similar type of work alongwith EMD. Financial bid should contain duly filled up Annexure I of the Notice Inviting Tender. The above two envelopes may be sealed by the bidder separately duly super-scribed as technical and financial bids and these two sealed covers are to be put in a bigger cover which should also be sealed and duly super-scribed as the Tender No. A bidder who submits more than one bid shall be disqualified.**
- 3. TDS as applicable on date will be deducted from the bill at source.**
- 4. The rate quoted will be exclusive of VAT and it should be mentioned separately.**
- 5. NIT Patna reserves the absolute right to accept or reject any or all the tenders on whole or in part without assigning any reason thereof.**
- 6. NIT Patna reserves the right to reject any articles/services found defective damaged/or not of the desired quality and specification. Decision of NITP will be final.**
- 7. Any loss or damage caused to the article in transit is to be made good by the supplier free of cost within reasonable time.**
- 8. Agency desiring to obtain Notice Inviting Tender (NIT) by Post or Courier must send a Demand Draft of Rs. 550/- which will include Rs. 50.00 postal charge in favour of the Registrar NIT Patna payable at Patna.**
- 9. Postal or courier delay will not be considered and the Tender received late will be rejected without assigning any reason.**
- 10. Earnest money of Rs 10,000/-(refundable) should be enclosed, in the form of Account Payee DD/Bankers Cheque. drawn in favour of the Registrar, NIT Patna payable at Patna.**
