**PREQUALIFICATION OF CIVIL CONTRACTORS FOR CONSTRUCTION OF
GIRLS HOSTEL, STUDENT ACTIVITY CENTRE, BOYS HOSTEL AND NEW
BOYS HOSTEL AT NIT PATNA.**

National Institute of Technology Patna invites application for empanelment of contractors for civil works including Development works, water supply, sanitary installation fire fighting and electrical for construction of the above mentioned four buildings at NIT Patna. The estimated value of the work is approx. Rs.103 crores which is to be completed in 18 months. The contractor who fulfill the following criteria may apply.

1. Experience having successfully completed similar works in last five years ending on 31.03.09 as under:
 - (i) At least one similar work costing not less than Rs.8300 lacs or two similar works costing not less than Rs.6300 lacs or three similar works costing not less than Rs.4200 lacs
 - (ii) Similar works means construction of Hostel building /Public and Semi Public Building (Multistoried framed structure) for central/state governments Public sector or Financial institutions.
 - (iii) Average Annual financial turnover (for civil construction work only) during last three years ending on 31.03.09 should be more than Rs.5200 lacs. The total contract amount received as indicated in TDS Certificate issued by the client /employer would be considered for assessment of annual financial turnover.
 - (iv) The applicant should not have suffered any loss in more than two financial years during last five years ending on 31.3.2009.
2. The eligible contractor may send their application along with following details and documents on the enclosed proforma A to D.
 - (i) Name address and registration details of the firm with the name of the proprietor/ partner/ Directors
 - (ii) Name and address of the Banker and Banks solvency Certificate for an amount Rs.4160 lacs as indicating the financial capability of the firm. The certificate should not be more than two months old.
 - (iii) Photocopies of TDS certificate issued by the client/employer for the period 01.04.06 to 31.3.2009.
 - (iv) Photocopy of the income tax returns for the last five years ending on 31 March 2009.
 - (v) List of works executed since 01.01.2004 of minimum qualifying value as mentioned above alongwith photocopies of the completion certificates from the client/employer and copies of the work orders. Works below the required value or non similar works should clearly be mentioned. It should also be clearly stated if the works executed involved construction of basement or not.
 - (vi) Details of civil suits/ litigation/arbitration arising in the contracts executed during the last 5 years.
 - (vii) List of technical persons, equipments tools and plants etc. available with the contractors for the proposed work. For technical person it should be clearly mentioned that since what date they are working with this firm.
